Basic Information:

- 1. Property address where the addition will be constructed.
- 2. Owner's residential address.
- 3. Registered phone number for government notifications.
- 4. Registered email for government notifications.

- **2.Fill Out the Application:** Enter accurate details of the addition (area, purpose, location).
- **3.Upload Documents:** Attach all required documents in digital format.

 - **5.Receive Final Approvals:** From the Municipality and other concerned service authorities.
